- 2. Interactions with other non-UNLV volunteers including, but not limited to children, adolescents, and adults;
- 3. Inclement weather can impact safety (rain, cold, wind, heat); appropriate clothing and dress is required for each day's activity;
- 4. Use of equipment including, but not limited to: handheld tools such as a hammer, rake, paintbrush, shovel and electric tools such as nail guns, weed trimmers;
- 5. Manual labor including, but not limited to: lifting, reaching, stretching, and moving objects individual should be aware of own physical limitations;
- 6. Eating meals and snacks purchased and/or prepared by local businesses, residents or trip participants;
- 7. Working in a kitchen with associated tools and appliances (knives, stoves, ovens, dishwasher);
- 8. Staying in rented facilities including, but not limited to hostels, camp sites, and faith community buildings (these facilities could include cooking, sleeping and bathing facilities, & may also be used by non-UNLV participants)
- 9. Exposure to community conditions due to urban nature of area;
- 10. Exposure to community conditions due to rural nature of area;
- 11. Participation in recreational activities provided by affiliated staff including options such as visiting tourist attractions;
- 12. Working with volunteers from various community organizations;
- 13. Exposure to and interaction with clients of partnering nonprofits and community agencies.

Knowing this information, in consideration of my participation in service programs through Service Learning and Leadership (UNLVolunteers) sponsored by Service Learning and Leadership, I expressly and knowingly release the Board of Regents of the Nevada System of Higher Education (NSHE) on behalf of the University of Nevada Las Vegas (UNLV) and Service Learning and Leadership, and the State of Nevada their officers, agents, volunteers, and employees, from any and all claims and causes of action for property damage, personal injury or death sustained by me arising out of any travel or activity conducted by or under the auspices of Service Learning and Leadership caused by risks associated by this activity and/or the negligence of the sponsoring group.

In addition, I understand and agree that Service Learning and Leadership cannot be expected to control all of the risks articulated in this form but may need to respond to accidents and potential emergency situations. Therefore, I hereby give my consent for any medical treatment that may be required during my participation with the understanding that the cost of any such treatment will be my responsibility. **UNLV does not carry medical or accident insurance** for the activities mentioned unless the participants are informed otherwise. As such, participants should review their personal insurance portfolio.
