Assumption of Risk / Release of Liability Form**

I understand and agree that the Metro PD/ Boys & Girls Club Holiday Event sponsored by the University of Nevada, Las Vegas (UNLV) Student Involvement & Activities and Community Engagement may involve certain risks and that regardless of the precautions taken by Student Involvement & Activities and Community Engagement, some bodily injuries may occur.

Specific risks/hazards involved in my voluntary participation in the **Metro PD/ Boys & Girls Club Holiday Event** include, but are not limited to the following:

1. *Inclement weather at outdoor event*
2. *Interaction with members of the public / clients of Boys and Girls Club*
3. *Physical labor involved with event set-up, tear-down, and running event carnival games*

I understand that the above description of these risks is not complete and that there are unknown or unanticipated risks that may result in injury, illness or death.

Knowing this information, in consideration of my participation in Metro PD/ Boys & Girls Club Holiday Event I **expressly** and **knowingly release** the Board of Regents of the Nevada System of Higher Education, on behalf of the University of Nevada, Las Vegas (UNLV), their officers, agents, volunteers, and employees, against any and all liability, claims, demands, losses, judgments, damages or causes of action, including attorney's fees and other expenses, which may arise from or in connection with my voluntary participation in [insert specific activity or program] or which are caused by risks associated with my participation in the above listed activities.

In addition, I understand and agree that Student Involvement & Activities and Community Engagement cannot be expected to control all of the risks articulated in this form but may need to respond to accidents and potential emergency situations. Therefore, I hereby give my consent for any and all medical treatment that may be required during my participation with the understanding that the cost of any such treatment will be my sole responsibility.

I understand that **UNLV does not provide medical or accident insurance** for my participation in the activities, and that I am solely responsible for any medical costs arising out of my participation in this Metro PD/ Boys & Girls Club Holiday Event.

I **voluntarily** and **knowingly** agree to **protect**, defend, **hold harmless**, and **indemnify** the Board of Regents of the Nevada System of Higher Education (NSHE) on behalf of the UNLV, their officers, agents, volunteers, and employees, against any and all liability, claims, demands, losses, judgments, damages or causes of action, including attorney's fees and other expenses, which may arise from or in connection with my voluntary participation in [insert specific activity or program] or which are caused by risks associated with my participation in the above listed activities.
